Hong Kong Institute of CPAs takes disciplinary action Against a certified public accountant

(HONG KONG, 18 March 2010) – A Disciplinary Committee of the Hong Kong Institute of Certified Public Accountants ordered on 29 January 2010 that the name of Ou Ka Chi (membership number F02349) be removed from the register of certified public accountants for a period of 10 years due to his conviction in Hong Kong of two offences involving dishonesty.

In addition, Ou was ordered to pay HK\$93,000 towards the costs of the disciplinary proceedings.

In 2005, Ou was convicted of two counts of conspiracy to defraud, under section 159C(6) of the Crimes Ordinance (Cap 200). Ou was then the financial controller of a company listed on the Hong Kong Stock Exchange and he was found to have conspired with the company's managing director to defraud various subsidiaries of the company. Ou was sentenced to imprisonment for four years and seven months. After considering the information available, the Institute lodged a complaint against Ou under section 34(1A) of the Professional Accountants Ordinance.

The Disciplinary Committee found the complaint against Ou proven. Having taken into account the evidence and circumstances of the case, the Disciplinary Committee ordered that Ou:

- be removed from the register of certified public accountants for a period of 10 years from 28 February 2010; and
- pay HK\$93,000 towards the costs of the disciplinary proceedings.

Disciplinary proceedings of the Institute are conducted in accordance with Part V of the Professional Accountants Ordinance by a five-member Disciplinary Committee. The majority (three members) of each committee, including the chairman, are non-accountants chosen from a panel of lay persons appointed by the Chief Executive of the HKSAR, and the other two members are CPAs.

Disciplinary hearings are held in public unless the Disciplinary Committee directs otherwise in the interests of justice. A hearing schedule is available at the Institute's website. A CPA who is aggrieved by an order made by a Disciplinary Committee may appeal to the Court of Appeal, which may confirm, vary or reverse the order.

The Disciplinary Committees have the power to sanction members, member practices and registered students. Sanctions include temporary or permanent removal from membership or cancellation of a practising certificate, a reprimand, a penalty of up to \$500,000, and payment of costs and expenses of the proceedings.
