Proprietor charged with \$200,000 bribery over air-condition piping works

The proprietor of an air-condition engineering company has been charged by the ICAC today (March 20) with conspiracy for a then assistant project manager of another engineering firm to accept an illegal rebate of about \$200,000 for recommending air-condition piping works of a commercial complex to the air-condition engineering company.

So Sung-loi, 53, sole proprietor of Wan Laiai Air-Condition Engineering Company (WLAC), faces a charge of conspiracy for an agent to accept advantages, contrary to Section 9(1)(a) of the Prevention of Bribery Ordinance and Section 159A of the Crimes Ordinance.

The defendant will appear in the West Kowloon Magistracy on Wednesday (March 22) for plea.

At the material time, the defendant was the sole proprietor of WLAC, an air-conditioning renovation contractor.

The charge alleges that between September 1, 2013 and November 30, 2014, the defendant conspired together with a then assistant project manager of another engineering firm for the latter to, without lawful authority or reasonable excuse, accept approximately \$200,000 cash from him as a reward for recommending for subcontracting air-condition piping works in the renovation project of Yau Oi Commercial Complex in Yau Oi Estate, Tuen Mun to WLAC.

The defendant has been released on ICAC bail, pending his court appearance on Wednesday. Back to Index

廉署起訴公司東主疑涉空調管道工程二十萬元非法回佣案

2017年3月20日

廉政公署今日(三月二十日)落案起訴一名冷氣工程公司東主, 控告他涉嫌與另一間工程公司的一名前助理項目經理一同串謀, 使後者收受約二十萬元非法回佣, 以推薦將一個商場的空調管道工程分判予該冷氣工程公司。

蘇送來, 五十三歲, 運來冷氣工程公司(運來)獨資東主, 被控一項代理人串謀接受利益罪名, 違反《防止賄賂條例》第9(1)(a)條及《刑事罪行條例》第159A條。

被告將於星期三(三月二十二日)在西九龍裁判法院答辯。

案發時運來是一間空調系統裝修承辦商,被告是該公司的獨資東主。

控罪指被告涉嫌於二○一三年九月一日至二○一四年十一月三十日期間,與另一間工程公司的一名前助理項目經理串謀,使後者在無合法權限或合理辯解下從被告收受約二十萬元現金,作為推薦將屯門友愛邨友愛商場翻新項目的空調管道工程分判給運來的報酬。

被告已獲廉署准予保釋,以待星期三應訊。 返回目錄
